- The qualifications of the Cook should meet and be in compliance with the standards established by Chapter 65C-22 of the Florida Administrative Code, Child Care Standards.
- Previous food preparation/handling experience in a child care setting is preferred.
- Course work and/or training in foods, nutrition and/or dietetics is preferred.
- Current Food Handlers Certification is preferred.
- Must have sensitivity to the service population's cultural and socioeconomic characteristics.

PRIMARY DUTIES AND RESPONSIBILITIES

- Establishes a warm and friendly, yet objective relationship with the children.
- Maintains a good knowledge of State regulations regarding food preparation.
- Provides care and protection of children and meets their individual needs.
- Helps children foster appropriate eating habits.
- Participates in State and CCRN required training.
- Ensures that equipment and materials are accessible and in good condition.
- Dress appropriately and neatly, and wears hair tied back.
- Washes hands frequently and is always aware of potential food contamination.
- Is aware of and uses proper dish washing and disinfecting techniques.
- Keeps a daily running inventory.
- Is able to plan nutritious menus, follow planned menus and order inventory of need in advance.
- Is able to prepare food according to the daily number of children in order to avoid waste or shortages.
- Keep all food storage areas including freezer and refrigerator clean and free of clutter.
- Leaves the kitchen clean, with everything put away, all surfaces disinfected and removes the trash at the end of shift.
- Is always friendly and helpful to children and staff and parents
- Maintains a regular maintenance schedule for in-depth cleaning and informs supervisor of needs.
- Completes paperwork required by CCRN food program and center director on daily basis. Responsible for all paperwork for food program (menus, meal counts, P.O.s, etc)
- Understands child to staff ratios and steps in to correct ratio in the event of an absent staff until replacement staff is available.

JOB POSTING

- Administers medications and documents on appropriate forms.
- Reports any significant problems of progress or any unusual behavior of children to the Director of the Child Care Center
- Remains in the Child Care Center during assigned hours, unless specifically assigned duty elsewhere.
- Performs all other duties as assigned.
