Although we at the Florida United Methodist Children's Home were hoping for the opportunity to send our children to the Warren W. Willis Camp in June, the pandemic led to the Camp closing its doors this summer. As such, we created an opportunity for the children to attend summer camp on campus. Summer camp has always been a highlight for children at the Children's Home. Thanks to the incredible generosity of the Simpkins Family Foundation, which funded and enabled the vision for this year's special summer camp experience to happen. The Foundation has also provided for some special activities to happen in the fall. Our Spiritual Life and Recreation departments designed an altered camp experience for our children, called Camp Rona. We felt confident that we would be able to put it on with all of the guidelines and safety precautions needed and still give the children an opportunity to grow. Our children and staff from the Madison Youth Ranch also came down to Enterprise and took part in the week-long camp. Once again, we are so grateful for the Simpkins Family Foundation!

The theme for the week was water and how God used water to provide for God's people and provide new life. Daily activities began at 9am and concluded around 3pm, just in time for the afternoon thunderstorms. The mornings began with devotions (similar to praise time at traditional summer camp), and each day included swim time. All of the activities were based around that theme, reminding people that God is with us. Daily themes included: messy, Olympics, nature, water, and game shows. Rev. Madeline Luzinski, the Director of Pastoral Care at the Children's Home, spoke of the impact of the week. "We wanted the week to feel very special, as if the children had actually left campus and gone to camp," she said. "The fact that they were able to do so many things outside of their normal routines, and to join with our children and staff from Madison, really made the week an energizing experience and a wonderful opportunity to reset."

Another special aspect of the week came courtesy of Community United Methodist Church in Casselberry, which provided for our July 4th celebrations: an ice cream party and a July 4th party. Following the children's participation in messy games, they were treated to an ice cream party outside. Both children and staff appreciated the opportunity to get cooled off, and both the ice cream and toppings were a huge hit. Then on Thursday we had the July 4th party by the pool. The kids enjoyed fried chicken, coleslaw, and watermelon, and then were able to play in the pool before the rest of water day. Thank you, Community UMC, for your continued support!

Testimonial From an Alumnus

"Before I came to the Children's Home, I had gone from therapist to therapist to work through 7 years of abuse. I became so depressed that I didn't even want to decorate our Christmas tree. The slightest criticism made me feel worthless and soon I felt that I didn't deserve to live. I was a mess. I had over 2,000 scars on my body and spent a total of 4 months in different hospitals. My GPA dropped from a 4.2 to a 0.3. But that was before I came to live here at the Children's Home.

That is not to say that I didn't have my ups and downs, and there were a lot more downs in the beginning – just ask my houseparents. But through all the stuff I put my family and my houseparents through, I finally learned to give up and let go. And then one day, just as easily as it sounds, everything completely changed. I sat and cried and talked to God until I had told Him everything I wanted and needed in this life. Then I told Him what I was going to do to get there. That was the moment when everything changed. I had given my life to the Lord and I let go of all my anger and sadness and moved on.

There have been many changes and "firsts" during my time here at the Home that I never expected to experience while living here. And as I become closer with the Lord I feel more and more compelled to work in the ministry field. There are a few times in a person's life when they are completely surrounded by absolutely amazing people. Living at the Home is one of those rare and lucky times. Whether it was my houseparents or other cottages, someone was always there for me to fill the void when I longed for my family.

To all the girls in my cottage, you have taught me so much, and it has been a blast. Looking back even the drama was fun. Among the hundreds of important things my stay at the Home as taught me is that there is a plan for every life, a purpose and meaning for everything and for what it's worth, I am sadder to be leaving here than I was to be coming here."
