Required Mandatory Distribution

Once a person reaches 70 ½, they are required to withdraw a minimum amount from their IRA. This required minimum distribution (RMD) is a certain percentage that must be taken. Some people don't need the money, so they can consider giving to a charity of their choice.

With the full economic impact of COVID-19 still to be seen, we know the importance of making your money go as far as possible. Instead of paying more in taxes, those that are 70 ½ can roll over up to \$100,000 from your IRA to the Florida United Methodist Children's Home. The transfer will not be taxed, and it counts against the required distribution.
