Enterprise Celebrates Day of Service

In what has become a beloved tradition, children and staff of the Florida United Methodist Children's Home's Enterprise campus took part in our annual Day of Service. Small groups of children and staff spread out amongst five locations in both Volusia and Seminole Counties to make a positive impact in the community. The work projects included:

- All Saints Episcopal Church, Enterprise Our youth pulled weeds and trimmed trees around the sanctuary and other buildings. Linda Eardman, Junior Warden, had this to say about her group, "The children were so very polite, courteous, well-mannered, just as they've always been. I was hard-pressed keeping up with them they kept coming back and asking what was next on the list."
- **Enterprise Preservation Society, Enterprise** There were multiple tasks performed by our youth that included trimming trees and bushes, raking, and cleaning the front of the building. "The children were very engaged, and one actually asked if he could come back and become a volunteer! They took directions well and paid a lot of attention to detail," said Ed Sullivan, Board Chairman.
- **Lakeside United Methodist Church, Sanford** Youth assisted with bringing the church's Christmas decorations from an outbuilding to the sanctuary, as well as moving boxes into an upstairs storage area. Marilyn Walls, Ministry Coordinator said, "They all worked so hard and worked great as a team together. Thank you for allowing them to help us and believe me it was a HUGE help."
- **Osteen United Methodist Church, Osteen** Youth did a lot of weeding and cleared trash and debris around the buildings.
- **First United Methodist Church of Sanford** Some light landscaping and weeding was done as well as cleaning windows and doors.

A Day of Service began back in 2019 and is usually done a couple of times a year. It has become an anticipated event for those at the Children's Home. Thank you for helping to enable this ministry, which has a huge impact on its surrounding community!
