

## Rev. Brian Carr Joins the Children's Home

We are excited to announce that Rev. Brian Carr will be joining our Leadership Team as the new Director of Church Relations. Rev. Carr currently serves at the First United Methodist Church in Port St. Lucie. He has been an ardent supporter of the Children's Home in his capacity as a United Methodist minister and has generously served on our Board of Trustees. Rev. Carr will be resigning from his Board position to join us as of July 1<sup>st</sup> and retiring from the Florida United Methodist Conference as of June 30<sup>th</sup>. While on our Board he has been a part of the Church Relations subcommittee, a part of the strategic planning process, and also has active with our Development Committee.

Originally from Mullens, West Virginia, Rev. Carr grew up in a loving, faith-filled, often-laughing family. He received his B.A. degree from Marshall University in Spanish. "The best thing that happened in college was a personal encounter with Jesus Christ which left me



forever altered," he says. He has served much of his life in the service of Christ: three years as a missionary in Mexico, four years as a Youth Director and is now in his twenty-fourth year of Ordained Ministry with the United Methodist Church after graduating from Asbury Theological Seminary in Wilmore, Kentucky.

After the huge privilege and blessing of serving on the Board of Trustees of the Children's Home where he got an inside view of the tremendous work done here in ever-challenging times, Rev. Carr said, "I'm delighted and honored to even be considered to serve with the beloved Florida United Methodist Children's Home." Once Rev.
